

# Law Enforcement 2012 Payment Schedule

This schedule reflects *training fees* only. Required tools and equipment are additional expenses. Because the Law Enforcement option is a 21-week course, it must be considered separately from other Advanced Training options.

**Law Enforcement (21 weeks):** Students must be 19 years of age and pass a background check and drug screening to enter the ALERT Police Academy. The one-week “Prevailing in Low-Light Conditions” course, taught by Strategos International, is **optional** for students. The cost of this course is \$885.00. The intensive course provides thorough instruction on low-light conditions that law enforcement officials often encounter. Students who opt not to take the course will be on deployment status the week of the class.
